Student employment has been shown to have a positive effect on students' decisions to stay in higher education. Experienced professionals are needed to mentor and support these students, while understanding the federal regulations which govern these programs.

NSEA will fund one (1) UPS Professional Development Scholarship per region, for student employment professionals to attend other training opportunities such as National Association of Financial Aid Administrators (NASFAA), National Association of Colleges and Employers (NACE), regional conferences such as NEASEA, SASEA, MASEA, WASEA or other comparable conferences. (Excluding annual NSEA conference)

Applications will be accepted from NSEA member institutions and must include a statement of the anticipated benefits of attendance. Each institutional grant recipient will receive a maximum of \$500 for conference registration fee and related expenses such as travel, hotel, meals, etc. Reimbursement will be made directly to the recipient's institution upon receipt of proof of paid registration and related expenses if applicable. *Preference will be given members who have not been able to attend a conference in the past, and institutions with no funding available for professional development.*
